

Our written agreement.





The steeper part of the roof is only 10.8 square.

I understand the roof was 11/12 and not 9/12. Whether the roof is 9/12 or 11/12, you can't walk on it. There was an extra layer to tear off on the 11/12 section. I will pay more than \$90 per square for this part, but I did not agree to pay \$130 per square. I will pay \$120. The actual square of the 11/12 roof is 10.8 square. I will pay 13 square for this steep part. I will not pay for 15 square. It is not 15 square. That is fraudulent billing on your part.

11/12: 13 square x \$120 = \$1560

5/12: 25 square x 85 = \$2125

Decking

46 sheets of OSB were purchased and delivered to the job site.




5 sheets were left over after the job was complete. We stacked them in the job for the homeowner.





46 - 5 = 41 sheets

Our agreement was \$25 per sheet. You had already been on the roof when you quoted me \$25 per sheet. You knew how steep it was when you quoted me that price.




You are trying to charge me \$30 per sheet for 43 sheets. Again fraudulent billing on your part.

I will pay: 41 x \$25 = \$1025

11/12 section. 13 square @ \$120 per square.	\$1560
5/12 section. 25 square @ \$85 per square.	\$2125
Decking. 41 sheets @ \$25 per square.	\$1025
Flashing 2 chimneys	\$300
20' of ridge vent	\$130
Gas	\$250
Your guy asked if I would get 2 hotel rooms for them. I said no. I said I would pay for 1 hotel room. He said reserve 2, and Pedro will reimburse you for one of them.	-\$84
You tore off part of the roof and covered it with ice and water barrier and told me it was water tight. The homeowner called me and said it blew off. We had to drive over there after hours to reattached the ice and water.	-\$100
The roof was not properly flashed where the step flashing ends, in 4 locations. It was just caulked. We had to finish your work, and flash it the proper way.	-\$135
